Consultation: Market mechanism for inertia The changing generation mix, with a higher share of wind and solar, means the power system has less inertia. Less system inertia means frequency may become volatile. If frequency changes too fast then the system is at high risk of going black. While the <i>Draft National Electricity Amendment (Managing the rate of change of power</i> <i>system frequency) Rule 2017</i> (June 2017) provides for a minimum level of inertia, the AEMC recommends that a market to obtain and pay for inertia above this minimum level would provide additional benefits.
